



Flex Our Power. Save Our Power.

When it comes to protecting our state's natural resources, we must work together, particularly if there is an energy emergency. A *Flex Alert* is a call for consumers to voluntarily conserve energy when there is an anticipated shortage of energy supply, especially if the grid operator needs to use reserves to maintain grid integrity.

During a Flex Alert, it is important for each of us to focus on when we use energy—not just how much. By moving some of our energy use to earlier in the day or later in the evening, we can align our usage to when cleaner energy is more abundant and there is less strain on our power grid.
